Dear Boarders:

It is hard to believe the summer is already gone. Hope each of you had a good summer and are ready for cooler weather. As fall approaches and everyone is back in school, we are organizing your group lessons and rides. In reviewing the board documents, I have revised them and am requiring each of you **to fill out new ones** making sure you are aware of the changes (**30 notice for leaving**). In order for me to have you and your horse(s) listed under my Care, Custody and Control Insurance, updated signed board documents are required by the insurance company.

In order to accommodate the group lesson schedule, **4 group lessons will be assigned** for your designated level each week. You can pick which 3 fit your schedule. In the boarder package you get:

- **3 group lessons not private lessons**, and 1 professional ride.
(so if you can't make all 3 in one week, you can enter a 4th in the next week)
- **Professional ride:** once a week, the day to be determined by Fran
- Lessons are exchanged for rides if you are on a full care package and have a new horse or you are injured and can't ride.
- If you are unable to take your lessons due to being out of town and are not on the full care package, **you will be charged full care for that week.**
- **Monday morning is open for hacking from 8-12.**
- **Friday is closed to riding unless it is a make-up day.** It gives the men time to prepare the rings and turn the horses out earlier in preparation for the weekend.
- **There will be no hacking Friday evenings unless supervised by an Equest trainer.**

At the beginning of the month, Vicky should be informed which 3 lessons you will take on a regular basis. In the event you cancel, let her know and which lesson you will enter to make-up. **Lack of 24- hour notice for cancellation applies.**

For the most part, all of you can go on a regular group package schedule. **Private lessons are not part of the package.** There will be exceptions in the case of a new horse, preparing for a horse show or for other problems that may arise. This is to be determined by Fran.

In closing, I thank you for being part of the Equest Family and look forward to the upcoming fall.

REQUIREMENTS:

1. All horses must have a current coggins test at the time of arrival and a vet certificate stating the horse is healthy, current on all immunizations and has been wormed at least two months prior to arrival. All horses at Equest are kept on the same immunization and worming schedule. Once you become a boarder your horse will be put on the barns schedule. The vets will bill you directly. No horse will be allowed on the premise without a negative coggins report or a vet certificate.

2. All owners must sign the boarder "Release, Waiver and Hold Harmless Agreement" prior to entering the premise with their horse. No one other than our hired professionals may ride your horse without written permission from you, the owner. This person may not ride without a Waiver being signed and will be asked to dismount until it is signed.

The above information has been reviewed by the OWNER and is true and correct. Owner hereby agrees to pay the above fees by the 10th of the month and give 10 days notice prior to departure. Any fees collected after the tenth will be assigned a \$25 late fee.
